Happy Summer!

We are halfway through 2017. The year began with the Awards Banquet celebrating the 2016 accomplishments of the Chamber with over 300 members. Your Chamber Board distributed the 2017 Business Directory to our local members and hosted our 4th Annual Fiesta Meet and Greet at NW Natural Gas. We have attended 3 Business after Hours, 11 Ribbon Cuttings, 3 Cash Mobs, 2 Extreme School Makeovers and 22 Wednesday Business Connections. We hosted the graduation of the 28th class of Leadership Coos . You saw us at the BBQ Blues & Brews and on Hwy 101 collecting numerous bags of trash at the Cleanup Brigade as our area celebrated the beginning of tourism season!

It has been a busy time for the community and our legislators. Your Chamber Legislative Action Team (LAT) has been following what is happening in Salem and at our local elections affecting small business.

The ill-conceived, poorly-written proposal, Measure 6-162, which was designed to create more unnecessary government regulation, ban the transit of fuels on highways and rails, burden taxpayers with new costs, and block future business development and job creation in our community failed by a landslide.

Measure 6-163: Coos Bay School Bond: A \$66 million plan to update, improve and expand Coos Bay Schools was shy of passing by just 32 votes. The BEST Bond committee is working together with the original members and several new members to craft a new bond proposal to get approved by the Coos Bay school board that will appear on the November 2017 ballot. The Legislation session is coming to an end on July 10<sup>th</sup>. It has been slow to roll forward. The major focus has been a budget package, PERS predicament, transportation package, small business tax increases and education funding. When there are official results, Tom Burdett the LAT Chair will report out.

There was a Large turnout on the June 27<sup>th</sup> FERC scoping hearing meeting for the Jordan Cove Project, Speakers were issued numbered cards and then called into a separate room to give their statements which were recorded. We will keep you posted as soon as we have more information from testimonies. Continued show of community support is still encouraged.

Example – Subject: Letter in Support of Jordan Cove LNG; Docket No. PF17-4-000. A simple letter of support for the project will go a long way.

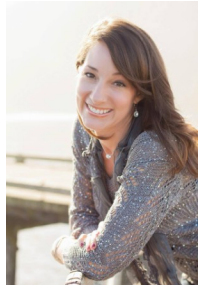

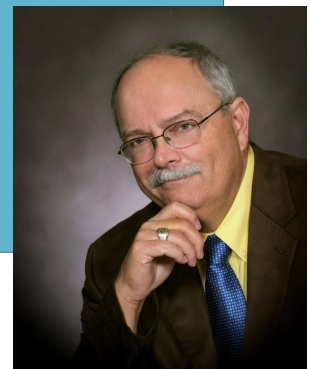
